## THE DIRECTOR

- CONSIDERING the project "Sustainable Precision Agriculture: Research and Knowledge for Learning how to be an agri-Entrepreneur "within the Erasmus + Program 2018 "Cooperation for Innovation and the Exchange of Good Practices Knowledge Alliances", of which the Department of Agricultural, Food, Environmental and Forestry Sciences and Technologies (DAGRI) is a partner;

### **ART. 1 - Indiction**

# **ART. 3 - Recipients**

The course is open to:

- Near-graduate, bachelor and master students at a European University
- Recently graduated students, not more than 24 months, at a European University
- PhD student in Agricultural Sciences

## ART. 4 - Commission

The Selection Commission of the competition, appointed by decree of the Director of


































DAGRI, will be composed of 3 members of the academic staff. The selection of candidates will be carried out first on the basis of the application submitted and, subsequently, the selected candidates will be invited for an interview also using the teleconference tool in audio and video via Skype.

#### ART. 5 - Evaluation criteria

For the evaluation, the Commission will have 60 points that will be assigned as follows:

- Motivation to participate in the initiative (max. 35 points)
- Knowledge of the Italian and English language (max. 15 points)
- Field of study at an Agricultural University or equivalent (max. 10 points)

The results of the final evaluation will be communicated by the Commission through a specific report, to be sent to the Director of DAGRI for the approval of the acts. The judgment of the Commission is final.

# ART. 6 - Ranking of admitted students

The ranking of those admitted, drawn up on the basis of the results of the evaluation made by the Commission of selection, will be deliberated with a specific decree of the Director of DAGRI, and will be announced by publication on the website of the Department (www.dagri.unifi.it).
